WHAT IS THE MINIMUM INVESTMENT?

The minimum to buy additional shares of each Fund is as follows:

- \$100 for all account types†

The minimum initial investment in each Fund is as follows:

- \$2,500 for regular accounts†
- \$1,500 for Retirement Accounts
- \$1,500 for UGMA/UTMA Accounts
- \$1,500 for Coverdell Education Savings

HOW MUCH MAY I CONTRIBUTE TO MY IRA?

Assuming you have earned income for the year in at least these amounts, you may generally contribute up to \$6,000 to your IRA for 2019 and 2020. If you are 50 or older, you may be able to contribute up to an additional \$1,000 per year.

The IRS deadline for 2019 contributions generally is July 15, 2020.
