Domini Impact Investments LLC (Domini) offers a check writing option to depositors in the Domini Deposit Account at PNC Bank (the Account). You must return a completed signature card to be eligible for check writing for your Account. You may withdraw funds by check provided that the proper signature(s) you designated are on the check. The minimum withdrawal amount by check is \$500. There is no charge for this service. You should not attempt to close your Account by check since you cannot be sure of the value of your Account. You must use the phone, online, or mail redemption feature to close your Account. Please note that each Account is subject to a \$3.00 monthly charge and a \$25.00 fee will be charged for any returned check.

TERMS AND CONDITIONS				

- 1. WITHDRAWAL AUTHORIZATION: The signatory(s) whose signature(s) appear here, intending to be legally bound, hereby agree each with the other and with Ultimus Fund Solutions (the Transfer Agent) that First National Bank of Omaha (the Bank) is appointed agent for such person(s) and, as such, agent is directed to request the Transfer Agent for Domini to withdraw funds from the Account registered in the name of such Signatory(s) upon receipt of, and in the amount of, checks drawn upon the above-numbered Account. Domini or its Transfer Agent shall apply the proceeds of such withdrawals to payments of such checks. The Bank and Transfer Agent are expressly authorized to commingle such proceeds with funds from transactions for other Account owners and shareholders of the Domini Funds. The Signatory(s) understand that the Bank may also act as an agent and custodian for the Domini Funds. The Bank and Transfer Agent are expressly authorized to honor checks as withdrawal instructions hereunder without signature guarantees, and neither the Transfer Agent, the Bank, or Domini shall be liable for any loss or liability resulting from the absence of any such guarantee.
- 2. CHECK PAYMENT: Each Signatory authorizes and directs the Bank to pay each check presented hereunder, subject to all laws and Bank rules and regulations pertaining to checking accounts. In addition, each Signatory agrees that:
 - a. No check shall be issued or honored, or any withdrawal effected, in an amount less than \$500
 - b. No check shall be issued or honored, or any withdrawal effected, for any amounts represented by check deposits held less than 15 business days unless payment for such deposits has been made in full and any checks given in such payment have been collected through normal banking channels or after a hold of up to 120 days for any amounts represented by ACH deposits.
 - c. No check shall be honored unless the Account has provided the Bank, from the withdrawal proceeds or otherwise collected funds for the payment of such check.
 - d. Checks issued hereunder cannot be cashed over the counter at the Bank or PNC Bank.
 - e. For new Accounts, a supply of checks shall be mailed approximately 60 days after a completed Signature Card is received by the Transfer Agent.
 - f. Checks shall be subject to any further limitations set forth in the Account paperwork issued by Domini including without limitation any additions, amendments and supplements thereto.
- 3. DUAL OWNERSHIP: If more than one person is indicated as a registered owner of the Account, as by joint ownership, ownership in common, or tenants by the entireties, then (a) each registered owner must sign this signature card, (b) each registered owner must sign each check issued hereunder unless the parties indicated on this card that only one need sign, in which case the Bank and Transfer Agent are authorized to act upon such signature, and (c) each signatory guarantees to the Bank and the Transfer Agent the genuineness and accuracy of the signature of the other Signatory(s).
- 4. TERMINATION: The Bank or Domini may at any time terminate this Account, related check writing service, and the Bank's agency for the Signatory(s)
- 5. HEIRS AND ASSIGNS: These terms and conditions shall bind the respective heirs, executors, administrators, and assigns of the Signatory(s)
